I write with the consent of Kevin Walsh, Esq. of Fair Share Housing Center to respectfully request an adjournment of the case management tele-conference currently scheduled for tomorrow morning at 9:00 a.m.

As Your Honor is aware, we attended mediation last Monday, October 21st, with the Honorable Philip S. Carchman, J.A.D. (ret.). Although the case did not settle, the parties remain close and Judge Carchman has been working to find common ground on the last remaining issues. Earlier this afternoon, Judge Carchman hosted a telephone conference with Princeton and Fair Share, and was scheduled to have a separate conversation with Robert Kasuba, Esq.
